#### **Ecology Stewardship**

The Foundation's passion for ecology is rooted in our belief that appreciation, respect, and understanding of the elements that surround us will enhance the lands as well as our bodies and souls. Its with this belief that we want to connect our community to the Woodlands through education and observation.

At the Woodlands we:

- Encourage our guests to discover the wonders of the natural world through experiential and educational activities. Whether this is a serene walk through the grounds or a class with one of our experts, experiencing and learning about the natural elements is the goal.
- Focus on the restoration and awakening of the biodiversity of the preserve ecosystem. The LaSalle County landscape was originally home to a myriad of indigenous wildlife and it is the Foundation's honor to help restore and cultivate the ecosystem that is native to the area.
- Collaborate with a coalition of interdisciplinary individuals, organizations, and community members to assist in the ongoing protection and preservation of the wildlife and ecology in our community. Our network of passionate experts and community aficionados is what helps drive our continual growth and improvement.

#### Health & Wellness Stewardship

We believe that connecting with nature is beneficial for the well-being of both humans and the natural world. It's been shown to lower stress, blood pressure and heart rate, while encouraging physical activity and buoying mood and mental health. Some research even suggests that green space is associated with a lower risk of developing psychiatric disorders — all findings that doctors are increasingly taking seriously and relaying to their patients. A new study published in the International Journal of Environmental Health Research adds to the evidence and shows just how little time it takes to get the benefits of being outside. Spending just 20 minutes in a park — even if you don't exercise while you're there — is enough to improve well-being, according to the research. Personal wellness education better positions people of all ages to develop and achieve their goals, develop healthy lifestyle habits, make healthy and informed decisions, and contributes to overall happiness.

Its with this belief that the Foundation is committed to comprehensive health education that promotes healthy habits and healthy relationships. We offer this through classes, seminars, and local resources who are available in the Wellness Center.

#### **Arts Stewardship**

Art at the Woodlands encourages a strong reciprocal relationship between people and the landscape as expressed through their artform of choice whether it be in the Fine Arts or performing arts. Nature has the capacity to inspire, promote curiosity, and generate creative ways of thinking and its our belief that the Woodlands will be an exceptional place of inspiration for our artists.

We will convene artists across a myriad of disciplines, helping our guests and participants explore subjects through an inquiry-based approach.

#### What Does It Take to Be a Volunteer?

A volunteer with Nell's Woodland is defined as a person who donates his or her time and effort to help Nell's Woodland fulfill our mission. This may include assisting in environmental education programs, natural areas management, cultural preservation and/or public relations.

The Nell's Foundation requires an individual be at least 16 years of age to volunteer. However, there are activities appropriate for younger individuals and groups if they are accompanied by an adult and have permission in writing from a parent/guardian. Individuals volunteering for a steward position Costewards and apprentice stewards may be 18 years and older.

#### **Position Description**

**Purpose of Volunteer Service:** To present basic concepts of ecology and natural history to school and general public using hands-on activities and interpretive techniques.

Supervisors: Naturalist, Volunteer Coordinator

Typical Assignment: Lead students on interpretive hikes through our woodland.

<u>Nature Center Host</u> <u>Volunteer</u>

#### **Position Description**

**Purpose of Volunteer Service:** To greet Ecology Center visitors, answer questions, concerns and present basic concepts of the Woodland ecology and natural history on request. Volunteers greet in the lobby, assist with questions and concerns, and engage with visitors within the woodland.

Supervisors: Naturalist, Volunteer Coordinator

Typical Assignment: Serve as a Nature Center host/hostess on weekends and/or weekdays

#### **Special Events Volunteer**

#### **Position Description**

Purpose of Volunteer Service: To assist staff in offering seasonal special events for the general public.

Supervisors: Naturalist, Volunteer Coordinator

**Typical Assignment:** Work at an assigned station during a special event, helping to set-up, greet visitors, assist visitors with the activity at your station and help to clean up after the event is over.

#### **Steward Volunteer**

#### **Position Description**

**Purpose of Volunteer Service**: To assist with the multi-faceted efforts of restoring, protecting and perpetuating native ecosystems consistent with Nell's natural areas management program. To share knowledge obtained with volunteers, staff and the public.

Supervisors: Restoration Ecologist, Volunteer Coordinator

**Typical Assignment:** The management of our site, working with the restoration staff to meet the goals for annual management

**Training:** Stewards begin as apprentice stewards, working with a mentor steward for one to three years. Volunteers are required to attend the Volunteer Orientation and will receive hands-on training in the field.

Apprentice Steward Volunteer

#### **Position Description**

**Purpose of Volunteer Service:** To learn the multi-faceted efforts of restoring, protecting and perpetuating native ecosystems consistent with Nell's natural areas management program. To share knowledge with other volunteers, staff and the public. To achieve the status of full volunteer steward.

Supervision: Site Steward, Restoration Ecologist, Volunteer Coordinator

**Typical Assignment:** To cut brush, build burn piles, pull herbaceous weeds, harvest seed and perform other tasks during restoration workdays. Work closely with a Steward with the goal of becoming a steward.

**Training:** Volunteers are required to attend the Volunteer Orientation and will receive hands-on training from a Mentor Steward for one to three years.

#### Workday Volunteer

#### Position Description

**Purpose of Volunteer Service:** To assist the site Steward with efforts to restore and protect native ecosystems.

Supervisors: Site Steward, Restoration Ecologist, Volunteer Coordinator

**Typical Assignment:** To cut brush, build burn piles, pull herbaceous weeds, harvest seed and perform other tasks during restoration workdays.

#### Seed Harvest Volunteer

**Position Description:** Purpose of Volunteer Service: To assist the restoration staff in collection of native plant seeds, which will be used to reestablish native plant communities in the woodland.

Supervisors: Restoration Ecologist, Volunteer Coordinator

**Typical Assignment:** Use hand tools to harvest woodland, prairie or wetland seeds at preserves throughout the county.

#### Adopt-A-Trail Volunteer

#### **Position Description**

Purpose of Volunteer Service: To help maintain the aesthetic and natural quality of the Nell's

Woodland, Supervisors: Volunteer Coordinator

**Typical Assignment:** Community groups, organizations and individuals may adopt a section of the trail systems to promote trail usage by reporting on the conditions of the trail and collecting refuse from the trail area.

- I agree to operate within the scope of the duties associated with my volunteer position, whether performing those duties on or off Nell's property (as in the case of special events). I have received the required orientation from my Nell's staff contact and/or the Nell's Volunteer Coordinator, and I understand what my volunteer duties entail. I understand that, in accepting the position as a Nell's Woodland Volunteer, I am agreeing to follow all rules, regulations, guidelines and policies presented during orientation.
- 2. I understand that I am not and will not be considered an employee of Nell's Woodland, nor will my involvement lead to employment, nor will I receive compensation for my services. I understand that I am at all times to follow the supervision and direction of the Nell's staff members in the commission of any volunteer activity. I also understand that I do not supervise other Nell's volunteers unless specifically authorized to do so by Nell's staff.
- 3. I understand that my volunteer relationship with Nell's Woodland can be terminated at any time by either party. I understand that failure to abide by any of the rules, regulations and/or guidelines presented here or in any other form through Nell's may result in disciplinary action and/or my

dismissal as a Nell's Woodland volunteer. If my volunteer relationship is suspended or terminated, I will promptly return all Nell's supplies, equipment, records and other items in good, clean condition.

- 4. I understand that I am a representative of Nell's Woodland, and will conduct myself in a manner so as to present a positive image of Nell's to those who visit the facilities and preserve areas. This includes being courteous and helpful to visitors, and following guidelines for appropriate dress. I understand that I am not authorized to enforce the rules and regulations of Nell's Woodland. I further understand that I am not to give interviews, submit press releases, or otherwise interact with the media without prior approval from Nell's.
- 5. I understand that there are certain risks for injury in any outdoor program or activity, and that the staff and volunteers of Nell's Woodland will make every reasonable effort to ensure the safety and health of each volunteer or participant. Beyond this, I will not hold Nell's Woodland or its staff responsible, and I agree to assume full risk for any injury.
- 6. I hereby give Nell's Woodland consent to, and shall hold Nell's and staff harmless for, obtaining and/or administering emergency treatment to me in the event that I am unable to obtain prompt emergency medical attention on my own behalf as a result of illness, accident, or allergic reaction. I understand that I am responsible for reporting any accidents to the Volunteer Coordinator within 24 hours of the incident.
